The County Judge thereupon announced that the Resolution had been duly and lawfully adopted. The Resolution thus adopted follows:

RESOLUTION EXPRESSING INTENT TO REIMBURSE

The Fort Bend County Toll Road Authority (the "Authority") has recommended proceeding with the following capital improvements and major repairs, as provided in its 2024-2025 Capital Improvement Plan (collectively, "Projects"), as listed in Exhibit A, attached and incorporated herein for all purposes.

Fort Bend County (the "County") anticipates that it will issue tax-exempt obligations ("Bonds") to permanently finance the cost of the Projects, and the maximum amount of obligations the Authority expects to issue for the Projects is \$600,000,000;

The Commissioners Court of the County have determined that it is in the best interest of the County to use funds currently available in the Toll Road Revenue Fund to pay for the Projects, until the Bonds are issued to permanently finance the Projects;

NOW, THEREFORE, BE IT RESOLVED BY THE FORT BEND COUNTY COMMISSIONERS COURT THAT:

Section 1: The County hereby expresses its intent, within the meaning of Treasury Regulation § 1.150-2, as promulgated under the Internal Revenue Code of 1986, as amended, to reimburse the Toll Road Revenue Fund for the costs of the Projects upon the issuance of the Bonds.

Section 2: The County hereby directs this Resolution to be made a part of its books and records that are available for inspection by the general public.
