When the following were heard and the following orders were passed:

- 1. **Call to Order.**
Call to Order by Judge KP George at 9:01 a.m.
- 2. **Conduct Budget Workshops.**

Pamela Gubbels, Director of Finance & Investments, presented the FY2026 budget request. The Fort Bend County preliminary tax values were received in April. The 2025 preliminary values for Fort Bend County are \$124.6 billion, which is a 1.84% increase over the prior year. The Drainage District preliminary values are \$123.2 billion, which is a 1.48% increase over the prior year.

The total dollar increase for Fort Bend County was \$2.25 billion over the prior year. The value of the existing property is \$121 million, which is almost a 1% decrease over the prior year. The new property value is \$3.3 million, which is an 11% increase over the prior year for the new improvements and property. The 1.84% is primarily coming from new improvements and properties. The revenue received from the new improvements and property is \$13.6 million. The property tax revenue, if the tax rate is the same as last year, will be almost \$500.5 million.

The value of new improvements and property for the Drainage District is \$3.3 million, which is an 11% increase. The value of the existing property decreased by 1.25% for a total of 1.48% increase from the prior year. The property tax revenue, if the tax rate is the same as last year, which is one cent, will be \$12 million.

The FY2026 budget request is \$845.6 million, which is a 15.6% increase or a \$114 million increase.

Ed Sturdivant, County Auditor, spoke on Debt Service and HB19 including the 20% limitation.

Item 2 continued - Conduct Budget Workshops:

Commissioner Meyers updated the court on HB19 and OPEB debt.

The FY2026 budget request includes 183 new positions for a total of \$21 million. The new vehicle requests are anticipated to be financed and are included in the debt service. There were 164 requested vehicles for a total of \$16 million, 132 replacements, which is 9.3% of our fleet and 32 are additions to the fleet, which is 2% of our fleet. Our current fleet has 1,420 vehicles.

Ms. Gubbels reviewed the Finance Summary and stated that in order to keep the same tax rate of 42 cents, we will have to reduce our General Fund budget request by \$90 million.

Jordan Wise, Chief Appraiser of the Fort Bend Central Appraisal District, spoke on Market Trends and discussed 2025 values. Residential values are up slightly, the commercial market is down slightly and land values are still up, but overall stabilized in Fort Bend County.

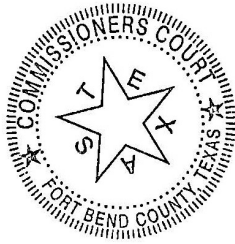
