Commissioner Prestage explained the funding source for this agreement is the ARPA Revenue Replacement, which was ARPA money granted to the County during the COVID 19 pandemic. The agreement is to provide transitional housing for victims of human trafficking and the church has the property and wherewithal to manage this effort. The County will participate in the construction of this facility, not the operation, of basic cottages that will house a hard-to-place population.

Commissioner Morales stated it is important to know the money will not be issued all at one time and will be funded upon items completed.

It is ordered to approve proposed changes to voting precinct lines as submitted to ensure that the number of active voters in each precinct does not exceed 5,000 . . .

There was a discussion between Commissioner Meyers and Commissioner McCoy regarding who would make the motion for this item. Bridgette Smith-Lawson, County Attorney, reviewed the court's customary practice and indicated anyone could make the motion, and it is for the court to determine what is done customarily based on the court's historical practice.

Commissioner McCoy withdrew his motion.

Commissioner Meyers stated there were some concerns that the current redistricting map of 2021 did not meet the state's statutes, which is the reason we are going through this process. It was also discovered the adopted redistricting map probably does not meet federal laws. A memo from the Commissioner's attorney indicated a federal law does not allow governmental entities to use race as a factor in redistricting. There is also in question if the approved district map was reviewed by legal counsel or an expert demographer. Based on input Commissioner Meyers received from his town hall in the past few days, he has decided to pull Agenda Item 22B.

Judge George indicated redistricting is a political matter and this particular map came from his office. In reviewing the minutes from the redistricting meeting in 2021, there were comments made by Judge saying this map was created based on race. He was never told this was illegal. The map he presented was not the map approved. For the record, this particular map was presented to the Judge and he trusted his staff and this was presented to him the day of the voting. The current map was never reviewed by an outside legal consultant and county hired redistricting consultant. Judge George believes the court needs to continue to address this process and this issue and table this item.

Commissioner Meyers stated for the record, according to the County Judge and his staff, when Commissioner McCoy was County Judge's Chief of Staff he was the one who drew the map that was approved.

Commissioner McCoy shared he received an email from former Commissioner DeMerchant which states the map he presented was the map that was ultimately adopted by Commissioners Court.

Bridgette Smith-Lawson, County Attorney, explained this court should not take into consideration any documents prepared by Tony McDonald and any references or opinions by Joe Nixon. No court has determined our map is illegal. We should follow the guidance presented by Mr. Bob Bass at the October 8, 2021 meeting.

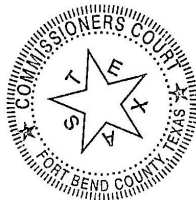
