4. Public Comments regarding the Agenda and Announcements.

Judge George read the statement below:

Before we begin today's meeting, I'd like to take a moment to remind all of us of the important responsibilities we carry as members of this Commissioners Court, and the others who support the commissioner's court in their respective rolls.

Last couple of sessions, we experienced several outbursts, that disrupted our proceedings and created confusion. It's essential that we maintain proper decorum so that our discussions remain clear, focused, and productive.

There are numerous people who work behind the scenes, take minutes, managing agenda items multimedia presentation management etc. including the disruption of the live streaming when it gets noisy. If this problem arises, I will recess the meeting to provide everyone an opportunity to collect themselves.

Moving forward I must ask that there be no clapping, shouting, or any other forms of loud or disruptive behavior during the court proceedings.

While we can agree or disagree with members of the court, the conversation must be in a respectful manner, and no one will be allowed to disrupt a court member while they are making their point.

Such actions interfere with the court's ability to conduct business with clarity, efficiently and respect.

As the presiding officer, I am asking that anyone wishing to address the court on a specific agenda item must wait to be recognized before speaking.

This ensures that only one person speaks at a time, promoting respectful and organized discussion.

If a commissioner wishes to challenge a ruling, raise a point of order, or seek clarification on parliamentary procedures, please do so respectfully.

Clearly state your point and wait to be recognized, at which point the matter will be addressed according to our adopted rules of procedure and Robert's Rules of Order. These protocols help ensure fairness and order in our deliberations.

I respectfully ask everyone to follow these guidelines: wait for your turn to speak, avoid interruptions, and treat one another with the respect during the court proceedings, always remember our citizens are watching.

By working together with professionalism and courtesy, we can conduct our future meetings more efficiently and effectively.

I ask for cooperation of all court members, other elected officials and our citizens in this matter.

Commissioner Meyers stated his understanding is Item 30B will be funded with Certificates of Obligations. Commissioner explained the County is not going to the voters and taxpayers to get their authorization and approval on a major capital expenditure, which will exceed \$40 million.

Ed Sturdivant, County Auditor explained where we stand with the County's debt. Currently, this item has a placeholder in the Certificates of Obligations being proposed for consideration by the court. The \$45 million is causing our Certificates of Obligation borrowing to be at about \$145 million. With regard to this item and any other items that affect debt service, it has created some strain on the upcoming budget process. There will need to be some reductions and we will likely have to pull from the borrowing group.

Pamela Gubbels, Director of Finance and Investment stated we are currently at a Fund balance of 24%. Ms. Gubbels has taken all of the new positions and programming out of the budget and we are still not at our 30% ending fund balance. Due to the debt service, Ms. Gubbels has moved three cents into Debt Service from the General Fund.

Commissioner Meyers noted the legislative session has ended and our legislatures are opposed to granting counties any authority to issue any more debt. Commissioner recommends we pause this item until we have a clear understanding of where we will be with the budget for this year and possibly next year.

Commissioner Morales indicated there was no backup on this item and nothing to show what was just described by the Budget Manager. Commissioner stated this item should not have been placed on the agenda. We need to take care of our employees and meet other obligations.

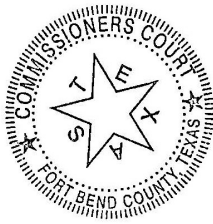
