FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL LANDSCAPE ARCHITECTURAL SERVICES ALL ABILITIES PARK

THIS FIRST AMENDMENT ("Amendment") is made and entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Bowman Consulting Group Ltd., previously known as Terra, a Bowman company, (hereinafter "Consultant"), a company authorized to conduct business in the State of Texas. County and Contractor are hereinafter collectively referred to as the "Parties" and each individually a "Party."

WHEREAS, on or about June 14, 2022, the Parties executed and accepted that certain Agreement for Professional Landscape Architectural Services All Abilities Park (hereinafter "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, by execution of this Amendment, the Parties desire to amend the Agreement to provide additional services by Contractor, to increase the Total Maximum Compensation for completion of such services, increase time of performance, and to otherwise ratify and confirm all the terms and conditions as set forth herein.

NOW, THEREFORE, in consideration of the foregoing, the Parties do mutually agree that the Agreement between the Parties is hereby amended as follows:

- 1. **Scope of Services.** County shall pay Consultant an additional Twelve Thousand Five Hundred and no/100 dollars (\$12,500.00) for the performance and completion of additional services as described in Consultant's Request for Approval of Additional Landscape Architectural Services dated March 25, 2025 (the "Services"), attached hereto as Exhibit A-1, and incorporated by reference for all intents and purposes.
- 2. **Limit of Appropriation.** Consultant understands and agrees that the Maximum Compensation payable to Consultant for Services rendered under this Agreement is hereby increased to an amount not to exceed Sixty-Seven Thousand Six Hundred and no/100 dollars (\$67,600.00), authorized as follows:

In no event shall the amount paid by County under this Agreement exceed the Maximum Compensation without a County approved change order. Consultant clearly understands and agrees, such understanding and agreement being the absolute essence of this Agreement, that County shall have available the total maximum sum of Sixty-Seven Thousand Six Hundred and no/100 dollars (\$67,600.00) specifically allocated to fully discharge any and all liabilities County may incur under the Agreement.

Consultant does further understand and agree, said understanding and agreement also being of the absolute essence of the Agreement, that the total Maximum Compensation that Consultant may become entitled to and the total maximum sum that County may become liable to pay to Consultant under the Agreement shall not under any conditions, circumstances, or interpretations thereof exceed Sixty-Seven Thousand Six Hundred and no/100 dollars (\$67,600.00).

- 3. **Time of Performance.** Time for performance of the Services under this Agreement is extended through December 31, 2028. Consultant shall complete the tasks described in the Scope of Services and Exhibit A-1 attached hereto, within this time or within such additional time as may be extended in writing by County.
- 4. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
- 5. **Modifications and Conflict.** Except as modified herein, the Agreement shall remain in full force and effect and has not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, this Amendment shall prevail with regard to the conflict.

I. SCOPE OF SERVICES:

Due to current unstable market conditions resulting in significant fluctuations in contractor pricing, Bowman has provided additional rounds of Value Engineering and Bid Phase services that have exceeded the originally projected budget for this task. In order to continue providing sufficient resources to ensure a smooth transition from the bid phase to the construction phase, as well as ongoing coordination with the selected contractor, Bowman proposes this additional services authorization.

00008 Additional Bidding and Construction Phase Services

Bowman will continue to provide bidding and construction phase services as originally scoped for the duration of the project. This includes all previously defined tasks, ensuring seamless project execution and adherence to design intent while addressing evolving project needs. Bowman will remain actively engaged throughout the process, facilitating coordination between the contractor, owner, and other stakeholders to address any project challenges that may arise. These efforts will help maintain project schedules, mitigate potential delays, manage unforeseen conditions, and ensure the successful delivery of a high-quality final product. This scope includes, but is not limited to:

A. Preconstruction Coordination:

- 1. Responding to contractor RFIs related to construction documentation and design intent.
- 2. Attending the preconstruction meeting to clarify project expectations, schedules, and responsibilities.
- 3. Reviewing contractor-proposed substitutions or value engineering alternatives for conformance with project requirements.

B. Submittal Review & Construction Administration:

- 1. Reviewing contractor submittals, shop drawings, and product data for compliance with project specifications.
- 2. Providing written responses to RFIs and requests for design clarifications.

3. Issuing supplementary details or design modifications as needed.

C. Site Visits & Field Observations:

- 1. Conducting periodic site visits to observe construction progress and verify compliance with contract documents.
- 2. Attending construction progress meetings as necessary.
- 3. Preparing field reports documenting site conditions, work progress, and any observed issues requiring attention.

D. Punch List & Project Closeout:

- 1. Performing substantial completion site reviews and generating a punch list of outstanding items.
- 2. Conducting follow-up site visits to verify completion of punch list items.
- 3. Reviewing closeout documentation, including as-built drawings and warranties.

These efforts will help ensure quality control, maintain design intent, and support a timely and efficient project completion.
