- (4) Attached as Exhibit A is a true, full and correct debt service schedule for all of the County's outstanding tax supported debt, including the Bonds. The principal amount of the County's total outstanding tax supported debt, including the Bonds and excluding the bonds refunded thereby, is \$______.
- (5) The currently effective ad valorem tax appraisal roll of the County (the "Tax Roll") is the Tax Roll prepared and approved during the calendar year 2023, being the most recently approved Tax Roll of the County; the taxable property in the County has been appraised, assessed and valued as required and provided by the Texas Constitution and Property Tax Code (collectively, "Texas law"); the Tax Roll for the year has been submitted to the Commissioners Court of the County as required by Texas law, and has been approved and recorded by the Commissioners Court of the County; and according to the Tax Roll for the year, the net aggregate taxable value of taxable property in the County (after deducting the amount of all applicable exemptions required or authorized under Texas law), upon which the annual ad valorem tax of the County has been or will be imposed or levied, is \$

- (8) With respect to the contracts executed in connection with the authorization and issuance of the Bonds, pursuant to Section 2252.152, Texas Government Code, the County has not entered and is not entering into a governmental contract with a company that is identified on a list prepared and maintained by the Comptroller of Public Accounts under Sections 806.051, 807.051, or 2252.153, Texas Government Code.
- (9) None of the bonds being refunded by the Bonds (the "Refunded Bonds") have ever been held in or purchased for the account of any of the interest and sinking funds created and maintained for the payment and security of the Refunded Bonds, and none of the Refunded Bonds are currently owned by and have ever been purchased or held for any account or fund of the County.
