**SEVENTH AMENDMENT TO AGREEMENT FOR JANITORIAL SERVICES
 FOR PARK FACILITIES AND PINNACLE SENIOR CENTER PURSUANT TO RFP 21-041**

THIS SEVENTH AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and High Quality Cleaning Services (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas. County and Contractor may be referred to individually as a "Party" or collectively as the "Parties."

WHEREAS, the Parties previously executed and accepted that certain Agreement for Janitorial Services for Park Facilities and Pinnacle Senior Center on March 23, 2021 pursuant to RFP 21-041 and was subsequently amended by document executed on and about March 8, 2022 (the "First Amendment"), July 12, 2022 (the "Second Amendment"), March 28, 2023 (the "Third Amendment"), January 23, 2024 (the "Fourth Amendment"), August 13, 2024 (the "Fifth Amendment"), and February 25, 2025 (the "Sixth Amendment") (collectively hereinafter the "Agreement");

WHEREAS, by execution of this Seventh Amendment, the Parties desire to further amend the Agreement to allow Contractor to provide additional Services under the Agreement, to change the Maximum Compensation for completion of such services, extend the Time for Performance under the Agreement, and to otherwise ratify and confirm all the terms and conditions as set forth therein.

NOW, THEREFORE, in consideration of the foregoing, the Parties do mutually agree that the Agreement the Parties is hereby amended as follows:

1. **Scope of Services.** County shall pay Contractor in accordance with the R21-041 Pricing Schedule for Park Facilities and Pinnacle Senior Center updated July 3, 2025, attached hereto as Exhibit "A" and incorporated by reference.
2. **Limit of Appropriation.** Contractor understands and agrees, such understanding being of the absolute essence of this Agreement, that County shall have available the total maximum sum of Three Hundred Seventy-Six Thousand Five Hundred and no/100 dollars (\$376,500.00), specifically allocated to fully discharge any and all liabilities County may incur. In no event shall the amount paid by County under this Agreement exceed the Maximum Compensation without a County approved change order.

Contractor does further understand and agree, said understanding and agreement also being of the absolute essence of the Agreement, that the Total Maximum Compensation that Contractor may become entitled to and the total maximum sum that County may become liable to pay to Contractor under

the Agreement shall not under any conditions, circumstances, or interpretations thereof exceed Three Hundred Seventy-Six Thousand Five Hundred and no/100 dollars (\$376,500.00).

3. **Non-appropriation.** Contractor understands and agrees that in the event no funds or insufficient funds are appropriated by the County under this Agreement, County shall immediately notify Contractor in writing of such occurrence and the Agreement shall thereafter terminate and be null and void on the last day of the fiscal period for which appropriations were received or made without penalty, liability, or expense to the County. In no event shall said termination of this Agreement or County's failure to appropriate said funds be deemed a breach or default of this Agreement or create a debt by County in any amount(s) in excess of those previously funded.
4. **Time of Performance.** The Time of Performance under the Agreement shall extend to end no later than March 31, 2026.
5. **Certain State Law Requirements for Contracts.** The contents of this Section are required by Texas law and are included by County regardless of content. For purposes of Sections 2252.152, 2271.002, and 2274.002, Texas Government Code, as amended, Contractor hereby verifies that Contractor and any parent company, wholly owned subsidiary, majority-owned subsidiary, and affiliate:
 - A. Unless affirmatively declared by the United States government to be excluded from its federal sanctions regime relating to Sudan or Iran or any federal sanctions regime relating to a foreign terrorist organization, is not identified on a list prepared and maintained by the Texas Comptroller of Public Accounts under Section 806.051, 807.051, or 2252.153 of the Texas Government Code.
 - B. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not boycott Israel and is authorized to agree in such contracts not to boycott Israel during the term of such contracts. "Boycott Israel" has the meaning provided in § 808.001 of the Texas Government Code.
 - C. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not boycott energy companies and is authorized to agree in such contracts not to boycott energy companies during the term of such contracts. "Boycott energy company" has the meaning provided in § 809.001 of the Texas Government Code.

- D. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association and is authorized to agree in such contracts not to discriminate against a firearm entity or firearm trade association during the term of such contracts. "Discriminate against a firearm entity or firearm trade association" has the meaning provided in § 2274.001(3) of the Texas Government Code. "Firearm entity" and "firearm trade association" have the meanings provided in § 2274.001(6) and (7) of the Texas Government Code.
6. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
7. **Human Trafficking.** BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.
8. **Modifications and Conflict.** Except as modified herein, the Agreement shall remain in full force and effect and has not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, this Seventh Amendment shall prevail with regard to the conflict.

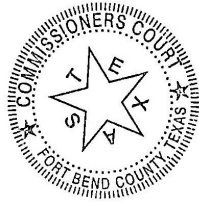
