AMENDMENT TO ADDENDUM TO DATAVOX, INC.'S AGREEMENT

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and DataVox, Inc., (hereinafter "DataVox"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Addendum to DataVox, Inc.'s Agreement on January 15, 2025, for the purchase of specified equipment and installation services, pursuant to TIPS RFP NO. 230105, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation under the Agreement for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay DataVox an additional amount not to exceed four hundred fifty-five and 64/100 dollars (\$455.64) to perform the additional Services, as described in DataVox's Proposal, attached hereto as Exhibit "A-1" and incorporated herein for all purposes.
2. The Maximum Compensation payable to DataVox for all Services rendered is hereby increased to an amount not to exceed fifty-one thousand nine hundred twenty-five and 10/100 dollars (\$51,925.10), authorized as follows:
 - \$51,469.46 under the Agreement; and
 - \$ 455.64 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without a written agreement executed by the parties.
4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

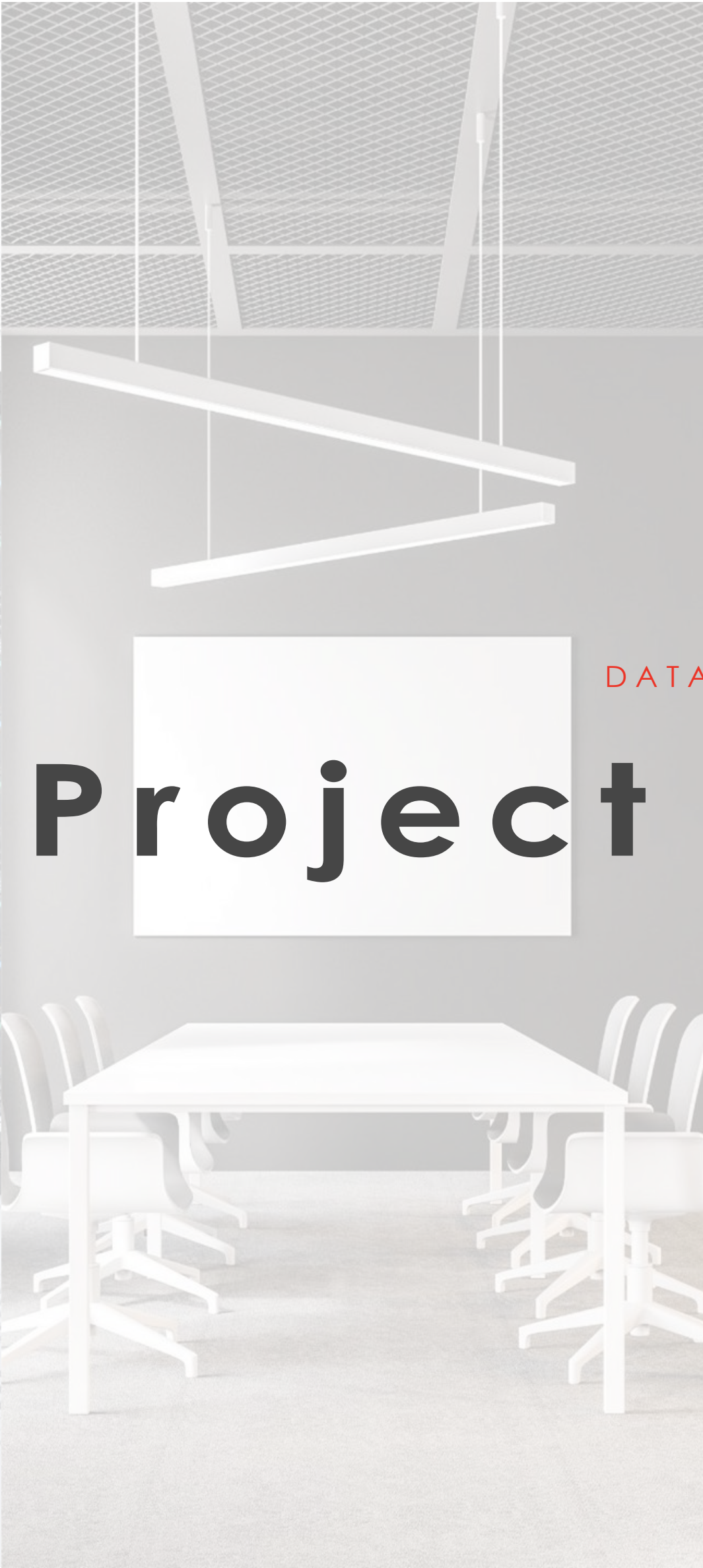
SCOPE OF WORK – PROJECT SPECIFIC ASSUMPTIONS & CONSIDERATIONS

- DataVox assumes all owner furnished equipment is fully functional and in good working order prior to on-site services. All OFE equipment is required to be located inside proposed installation room prior to on-site services.
- Customer is responsible for transportation, storage, or disposal of decommissioned AV equipment.
- Customer must provide plywood backing for each wall mounted display 75" diagonal or larger, or any size display with an articulating swing arm wall mount.
- Customer must provide (1) 15-amp circuit with duplex outlet at each display location.
- Customer must provide (1) dedicated 20-amp circuit with duplex outlet at each AV equipment rack location.
- DataVox has included Provisioning services for ClickShare XMS Cloud Management. This will provide remote device management for all ClickShares devices and other support devices.

SCOPE OF WORK – CLARIFICATION

- Request to keep current 55” displays rather than switching to DVX provided 43” displays
 - Can current displays be controlled?
 - Possible CO to swap to larger DVX provided displays

Decision was to quote two 55” displays
