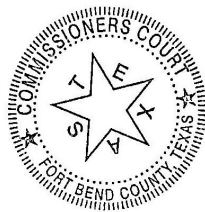
Judge George stated for the record all nine of the Executive Managers have been evaluated and the evaluation report will be a part of their personnel file.
