Datavox does further understand and agree, said understanding and agreement also being of the absolute essence of the Agreement, that the total Maximum Compensation that Datavox may become entitled to and the total maximum sum that County may become liable to pay to Datavox under the Agreement shall not under any conditions, circumstances, or interpretations thereof exceed Two Hundred Eighteen Thousand Four Hundred Eleven and 49/100 dollars (\$218,411.49).

3. **Time of Performance.** Time for performance of the Services under this Agreement is hereby extended and shall now terminate on December 31, 2025. Datavox shall complete the tasks described in the Scope of Services and in Exhibit "A-1" attached hereto, within this time or within such additional time as may be extended in writing by County.
4. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
5. **Modifications and Conflict.** Except as modified herein, the Agreement shall remain in full force and effect and has not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, this Amendment shall prevail with regard to the conflict.

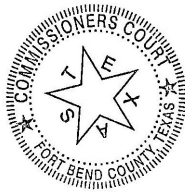

### Conference Room 1

  - DataVox will provide and install (1) Shure ANIUSB converter behind the display to convert Dante audio to USB into the video conference system. (1) Cat6 cable run to the AV network switch has been included.
  - DataVox will provide and install (1) Netgear 8 port POE+ network switch behind the display for IP connectivity.
- **Video Conferencing:**
  - DataVox will remove (1) Barco ClickShare Bar from the room.
  - DataVox will provide and install (1) Barco ClickShare CX-50 Gen2 wireless BYOD video conference system behind the display. The system includes (2) USB-C buttons and a tray accessory.
