County Clerk's Note: Mr. Oldham explained the map adopted by the Citizen's Advisory Committee was used to renumber the precincts and changes were made due to the congressional redistricting that occurred. We are now at four congressional districts instead of three, which had to be incorporated. Currently, there are 196 voting precincts instead of 175. There is some territory that will need to move from Precinct 1 back to Precinct 3 because the committee drew a line (crossing Snake Creek) that put two state house districts (85 and 26) in the same precinct.

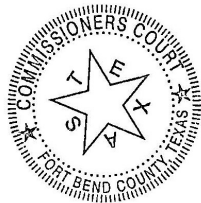
