
Toll road staff and consultants are hereby directed to submit a copy of this Resolution together with supporting material to Fort Bend County Commissioners Court for ratification and confirmation.

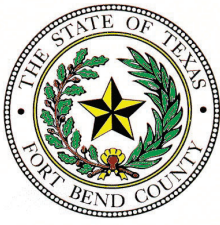

Dear Property Owner:

This letter is to inform you that Fort Bend County Engineering has determined that certain sign display occurring at the above-referenced property are in violation of the Sign Regulations Applicable to the Fort Bend Parkway, Westpark Tollway, and Grand Parkway Toll Road in Fort Bend County, Texas (herein referred to as "Regulations"). Fort Bend County Commissioners Court adopted these Regulations on April 23, 2019.

No.	Description of Violation	Section(s) of Regulations Violated
1)	Erecting a billboard sign visible from a Fort Bend County Toll Road. Billboard signs are prohibited.	Section 4 (f)

In order to avoid the payment of fines and/or penalties, you are required to take the following actions:

- **Remove the Billboard Sign and advertisement within 30 days from October 13, 2025.**

Should you fail to comply with the requirements of this violation notice and/or refuse to restore the subject property its pre-existing condition, Fort Bend County will initiate legal proceedings as cited in Section 2 of the Regulations.
