FIRST AMENDMENT TO TAX ABATEMENT AGREEMENT BETWEEN  
 FORT BEND COUNTY AND STARGAZER SOLAR LLC  
 Fort Bend County Reinvestment Zone No. 32

This FIRST AMENDMENT to the Tax Abatement Agreement (the "First Amendment") is made and entered into by and between FORT BEND COUNTY, TEXAS (hereinafter referred to as "County"), acting by and through its Commissioners' Court, and STARGAZER SOLAR LLC (hereinafter referred to as "Owner").

RECITALS

WHEREAS, the Parties entered into a Tax Abatement Agreement dated May 28, 2024 (the "Agreement") for Fort Bend County Reinvestment Zone No. 32 which is incorporated by reference; and

WHEREAS, pursuant to Section V(B)(1)(a) of the Agreement, Owner is required to complete construction and commence Commercial Operations not later than June 30, 2027 and

WHEREAS, Owner has submitted a request to Amend the Agreement, as documented in the attached letter dated October 21, 2025 which is incorporated for reference purposes only;

WHEREAS, the Parties now agree to amend the Agreement to extend the deadlines for commencement of construction and commencement of Commercial Operations by two-years, making the new deadline to commence construction June 30, 2027, and the new deadline to commence Commercial Operations June 30, 2029; and

WHEREAS, this specific two-year extension is being mutually agreed upon now, superseding the need for the conditional one-year extension provision in Section V(B)(1)(b) for this specific extension event; and

WHEREAS, this First Amendment is executed in accordance with the Property Redevelopment and Tax Abatement Act, Chapter 312, Texas Property Tax Code and the Fort Bend County Tax Abatement Guidelines and Criteria adopted by Commissioners Court on June 10, 2025.

NOW THEREFORE, for and in consideration of the mutual benefits to be derived by the parties hereto, County, and Owner agree as follows:

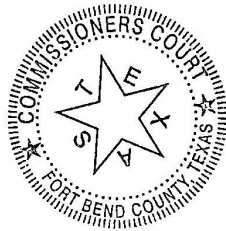
- I. Amendment to Section V(B)(1)(a) – Construction and Completion Deadline:  
 Section V(B)(1)(a) of the Agreement, under Performance Criteria, is hereby deleted in its entirety and replaced with the following:  
 Owner shall commence construction of the Project no later than June 30, 2027 and

shall complete the construction and commence Commercial Operations not later than June 30, 2029.

- II. No Amendment to Abatement Period:  
The parties acknowledge and agree that this First Amendment modifies only the Construction and Completion Deadlines and does not modify the definition or duration of the "Abatement Period" as defined in Section II(B), nor does it alter the PILOT TABLE in Section V(B)(3).
- III. Owner shall remit the required application fee pursuant to the Fort Bend County Tax Abatement Guidelines and Criteria adopted by Commissioners Court on June 10, 2025.
- IV. Except as modified herein, all other terms and conditions of the original Tax Abatement Agreement remain in full force and effect. In the event of any conflict between the terms of the original Agreement and the terms of this First Amendment, the terms of this First Amendment shall prevail.
- V. The Parties respectively represent and covenant that this First Amendment has, by proper action, been duly authorized, executed and delivered by the Parties.

IN TESTIMONY OF WHICH, THIS AMENDMENT shall be effective upon execution of all parties.
