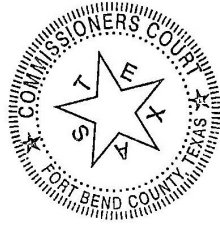

Whereas the Undersigned, hereinafter referred to as, "Member", desires to be serviced under the terms and conditions of the BuyBoard ("Customer") and AlSCO, Inc. ("Supplier") Preferred Vendor Program, AlSCO, "Supplier", located at 505 E 200 S, Salt Lake City, UT 84102, at The Member's location(s) at: _____, The Member agrees to the additional following terms and conditions:

- 1. The Member shall complete a credit application with Supplier.
2. The pricing and service program offered under the BuyBoard / AlSCO Preferred Vendor Agreement will be implemented in Member's location(s) upon approval of the credit application and the execution of this Service Authorization Form.
3. Member will be solely responsible for payment of charges in connection with the services provided by Supplier. The Member shall pay all invoices within 30 days following the date on which delivery is made. If Member applies for and is accepted by the Supplier for monthly billings, the terms are net 30 days from date of delivery. All balances not paid by the 30th day from the date of the invoice will be subject to a late payment charge of 1.5% per month (18% annual), but not to exceed the highest rate allowed by law.
4. If for any reason Member ceases to be affiliated with the BuyBoard program, Supplier will continue the BuyBoard / AlSCO pricing structure with Member until the end of the current service authorization period.
5. Member agrees that if the programs provided through this Service Authorization are terminated for any reason other than for cause during the term of said agreement, Member shall either pay the Supplier the greater of a sum equal to the number of unexpired weeks remaining in the term then in effect, multiplied by fifty percent (50%) of the average weekly charges for goods and services during the 10 weeks immediately preceding such termination; or purchase all goods in service at the replacement value listed on the BuyBoard / AlSCO Preferred Vendor Agreement, price list and the inventory will then become the property of the Member.
6. All goods supplied under this Agreement are, and shall remain, the property of Supplier. Customer shall be responsible for all goods which are lost, destroyed, stolen or not returned as required herein, and with respect to such lost, destroyed, stolen or non-returned goods Customer shall promptly pay to Supplier the Replacement Cost (as specified in the attached Schedule(s) or amended Schedule(s)) of such goods, including applicable sales and use taxes.
7. Member certifies that by entering this Agreement with Supplier, Member is neither breaching nor is Supplier infringing upon any existing contract between Member and any other uniform or linen service and will not engage in self-processing of linens, mats and uniforms supplied by AlSCO.
8. All items supplied by Supplier are designed for general use only. Supplier makes no representations or warranty that products are flame retardant, flame resistant or treated to resist acids or other caustic or hazardous materials.
9. This Service Authorization shall remain in full force and effect for a period of 36 months commencing on the date signed by Supplier and shall be automatically renewed for consecutive 12-month periods thereafter unless either party shall give to the other party written notice of termination by registered mail at least 90 days prior to the expiration of the term then in effect.
