

In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.

SpyGlass Group clearly understands and agrees, such understanding and agreement being of the absolute essence of this Agreement, that the total maximum sum of One Hundred Eighty Two Thousand Three Hundred Eight and 83/100 dollars (\$182,308.83), specifically allotted to fully discharge any and all liabilities County may incur under this Agreement.

SpyGlass Group further understand and agree, said understanding and agreement also being of the absolute essence of this Agreement, that the total maximum compensation that SpyGlass Group may be entitled to and the total maximum sum that County may become liable to pay SpyGals Group shall not under any conditions, circumstances, or interpretations thereof exceed One Hundred Eighty Two Thousand Three Hundred Eight and 83/100 dollars (\$182,308.83).

4. **Modification and Conflict.** Except as modified herein, the terms of the Agreement, as amended, shall remain in full force and effect and have not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, as amended, this Amendment shall prevail with regard to the conflict.




