

**SUPPLEMENTAL AGREEMENT NO. 1  
TO  
AGREEMENT FOR THE MAINTENANCE, OPERATION, AND REPAIR OF  
TRAFFIC SIGNALS ON GRAND PARKWAY (SH 99)**

This SUPPLEMENTAL AGREEMENT, which may be signed in multiple counterparts, shall be effective on the date provided below and modifies the AGREEMENT FOR THE MAINTENANCE, OPERATION AND REPAIR OF TRAFFIC SIGNALS ON GRAND PARKWAY (SH 99) originally dated effective as of September 6, 2011 (the "Agreement") by and between the Fort Bend Grand Parkway Toll Road Authority ("FBGPTRA" or the "Authority") and Fort Bend County, Texas (the "County").

The Agreement is hereby modified as follows:

1. The Agreement is modified by adding a new subsection (e) of Section 1.1, as follows:

(e) The Authority further agrees to pay or reimburse for the County for the replacement and installation of Signals and related components, including cameras, pedestrian heads, pedestrian buttons, signal heads, cabinets and backup battery units, at the locations and in the quantities and amounts shown in Exhibit D to this Agreement. The County shall bill the Authority for such costs in one or more invoices, and invoices shall be approved by the Authority within 45-days of receipt.

2. Section 1.5 of the Agreement is modified by replacing the notice address for the Authority with the following:

4. This Supplemental Agreement does not alter, modify, or otherwise change any other part of the Agreement, except as specifically stated in this Supplemental Agreement.
