

**AMENDMENT TO THE ADDENDUM TO AGREEMENT BETWEEN FORT BEND
COUNTY AND PRECISION TASK GROUP, INC.**

This Amendment (“Amendment”) is made and entered into by and between Fort Bend County (“County”) and Precision Task Group, Inc. (“PTG”) (together, the “Parties”), and amends the existing Addendum to PTG’s Agreement with County executed July 25, 2023, and made pursuant to Texas Department of Information Resources (“DIR”) Contract No. DIR-TSO-4242 (the “Addendum”).

WHEREAS, the Parties desire to continue the Subscription and Services provided under the Agreement and Addendum;

WHEREAS, the term of DIR Contract No. DIR-TSO-4242 has expired and the Parties intend to utilize DIR Contract No. DIR-CPO-5657 for all future Subscription and Services orders;

NOW THEREFORE, in consideration of the mutual promises and agreements herein contained, the Parties agree as follows:

1. Amendment to Contract Reference

Effective as of the date of execution of this Amendment, all references in the Addendum to DIR Contract No. DIR-TSO-4242 shall be deemed to refer to DIR Contract No. DIR-CPO-5657, solely with respect to any future Orders, Technical Services, Statements of Work, Change Orders, or amendments executed on or after the effective date of this Amendment.

2. Limit of Appropriation

The Limit of Appropriation for the performance of services as described on the order form shown in the attached Exhibit "A" is increased by \$38,428.00. The Limit of Appropriation payable to PTG for all Services rendered under the Agreement is hereby increased to an amount not to exceed \$7,994,531.60, authorized as follows:

- \$7,907,747.00 under the Original Agreement;
- \$29,039.00 under the Amendment;
- \$19,317.60 under the Second Amendment; and
- \$38,428.00 under this Third Amendment.

In no case shall the amount paid by County for all product and/or Services under the Agreement and this Amendment to the Agreement exceed the above Limit of Appropriation without an agreement executed by the Parties.

3. Survival of Prior Orders

All Subscription Orders, Technical Services, Statements of Work, and related documents previously executed under DIR Contract No. DIR-TSO-4242 shall remain valid, enforceable, and governed by the terms and conditions of DIR Contract No. DIR-TSO-4242 for their duration. Nothing in this Amendment shall be construed to alter or modify the obligations under any such prior documents.

4. Future Order Forms

Any new or renewed Order Forms, Change Orders, or Statements of Work issued after the effective date of this Amendment shall be executed pursuant to the terms of DIR Contract No. DIR-CPO-5657, and such contract shall govern all terms related to payment, services, indemnification, limitations of liability, and other provisions therein.

5. Limitation of Liability

The Parties agree that any prior references in the Addendum, Agreement, or incorporated documents to DIR Contract No. DIR-TSO-4242 in connection with Limitations of Liability (Addendum Section 23) shall be interpreted going forward to refer to the relevant sections of DIR Contract No. DIR-CPO-5657, to the extent such references apply to any new Subscription or Services orders.

6. No Other Modifications

Except as expressly modified herein, all other terms and conditions of the Addendum and incorporated Agreement documents shall remain unchanged and in full force and effect.

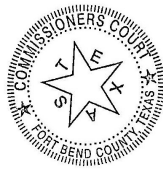


