When the following were had and the following orders were passed to wit:

**1. Call to Order:**

Call to Order by Judge Rozell.

**2. Discuss and consider appointment of vacancy in the office of Pct. 2 Constable:**

Bud Childers, County Attorney, presented the Attorney General's response on the vacancy and appointment of Constable, Pct. 2.

Commissioner Prestage stated that the voters who were present at the morning Commissioners Court meeting wanted the election process to select the next constable. He does not want a candidate to be considered. Therefore, he submitted a resume' for Samuel T. Ward, resident of Missouri City to fill the unexpired term of the Office of Constable, Pct. 2.

**Public Comments:**

David Jobert, Fort Bend County Sheriff Deputy, supports Mr. Ward.

George Pearson, resident of Missouri City, is not acquainted with Mr. Ward but will support him.

Samuel T. Ward, a resident of Missouri City, expressed his desire to serve as the appointed Constable, Pct. 2.

Moved by Commissioner Prestage to appoint Samuel T. Ward for the unexpired term of Constable Pct. 2. FAILED DUE TO LACK OF A SECOND.

Moved by Commissioner Lutts, Seconded by Commissioner Pressley, duly put and carried (3-1), with Commissioner Prestage voting no, it is ordered to appoint Fulton Cunningham to serve as the appointed Constable for Pct. 2.
